### GENERAL INFORMATION

Cell Power® Elona Fe can be used in combination with water soluble plant nutritional products which are formulated for foliar, sidedress or drip irrigation application. May be applied alone or in tank mixes containing fertilizers, fungicides and/or pesticides. Cell Power® Elona Fe is believed to be compatible with most agricultural watersoluble plant nutritional products that are difficient in iron. If physical compatibility with another fertilizer product is unknown, use a jar compatibility test.

## DIRECTIONS FOR USE

All Permanent Crops: Apply at 16-32 fl oz/acre near bloom. Continue at 16-32 fl oz/acre applications every two weeks during the fruit sizing period. One application pre-bloom at 16-32 fl oz/acre may be applied. All Field Crops and Hops: Apply as a foliar with sufficient water for good coverage at 16-32 fl oz/acre every two weeks.

All Fruiting Crops including, but not limited to Melons, Peppers, Tomatoes, Strawberries, Caneberries, and Blueberries: Begin application right after thinning/planting and make 2-4 total applications at 8-16 fl oz/acre every two weeks during the most active period of the crop's growth.

All vegetables including, but not limited to, all leafy vegetables and all root vegetables: Apply at 16-32 fl oz/acre when growing conditions are generating rapid shoot growth or to address nutrient deficiency. Use at 16-32 fl oz/acre 7 to 10 days ahead of harvest to increase size and dry matter content. Apply with sufficient amount of water. To be used only where there is a recognized

need. Do not exceed the appropriate dose rates.

Cell Power®Elona Fe may be applied at when iron deficiency is observed at a rate of 16-32 fl oz/acre every 2-3 weeks or as needed as a soil treatment. May be applied through various irrigation systems, including, but not limited to, furrow, side-roll, center pivot, linear, drip and micro irrigation systems.
